## LIABILITY WAIVER FIVB Beach Volleyball World Tour Cancun Hub 16 April – 2 May 2021

Given the current COVID-19 Pandemic and the efforts made by the FIVB, and the Local Organizer, important information is included in the [Events Regulations \(BVB-06\)](#) for the FIVB World Tour Cancun Hub, 16 April – 2 May 2021 in Cancun (MEX) regarding local regulations in place during the period of the event. Additionally, the FIVB has reviewed its protocols with its internal experts, including its Medical Commission, so that they can be adjusted to the current concerns facing all of us as a result of the pandemic. The FIVB and the local organiser want to ensure that all its stakeholders have all of the necessary information related to COVID-19 and have taken steps to minimize the potential risk of COVID-19. However, the FIVB and the local organiser note that a risk of COVID-19 still exists despite all efforts.

With the information provided in the Events Regulations, the FIVB's website and on the National Authorities websites, we would like to inform you of the possible risks involved in this Beach Volleyball World Tour Cancun Hub, including the travel to and from the event, and to highlight that you are participating in your own free will and that you are aware of and assume the possible risks related to the COVID-19 by participating in this event.

To be specific, by acknowledging this waiver and continuing to participate in the event after receiving this communication, you are aware of and agree that:

1. While the local protocols and personal discipline may reduce this risk, the risk still does exist; accordingly, your participation includes possible exposure to and illness from infectious diseases, including but not limited to COVID-19; and,
2. You knowingly and freely assume all such risks, both known and unknown, even if arising from the event and assume full responsibility for your participation in this event; and,
3. You willingly agree to comply with the local protocols and requirements in place in and outside the venue. If, however, you observe any unusual or significant hazards during the player presence or participation, you may remove yourself from the event and participation; and,
4. You confirm that you have not experienced any symptoms such as fever, fatigue, difficulty in breathing, or dry cough, or exhibited any other symptom related to COVID-19 within the last fourteen (14) days, nor have you been, or any member of your household, diagnosed to be infected with COVID-19 within the last thirty (30) days, **unless a negative PCR test result performed 72 hours prior to departure can be presented to the FIVB and local organizer.**
5. You have read the relevant BVB COVID-19 AND HYGIENE PROTOCOL along with the local organizer's protocol and understand their contents.
6. You, hereby release and hold harmless the FIVB, and the local organizer, including but not limited to officials, delegates, sponsors, staff, volunteers and other players with respect to any and all illness, disability or loss/damage to the player's person or property, whether arising from

the negligence of the organizers, participants or otherwise, to the fullest extent permitted by law.

7. This Waiver shall be governed by and construed in accordance with Swiss law, without regard to its conflicts of law provisions

We kindly ask that you reflect on the above and take the time to seriously consider the implications of the above on you and your families before taking a decision as to whether you wish to participate.

Should you not wish to participate in the event after receiving this communication, you may withdraw from the event by communicating your withdrawal to the FIVB ([worldtour@fivb.com](mailto:worldtour@fivb.com)).

Should you disagree with any of the above or fail to return a signed copy of this waiver, please note that this will result in your immediate withdrawal from the event.
